April 5 - North Carolina ratified the Articles of Confederation.

April 10 - The French fleet arrived in America with provisions and arms, thanks to the efforts of Benjamin Franklin. April 17 - Battle of Bristol PA

April 25 - Capt. John Paul Jones and his crew capture the HMS Drake. April 27 - Capt. John Paul Jones and his crew attacked Whitehaven England and burned the

HMS Thompson.

April 29 - Benjamin Franklin received the support of King Louis XVI and of Voltaire -- a famous French writer.

### April 27-28, 1778 at Whitehaven, England

On April 27-28, John Paul Jones leads a detachment from the U.S.S. Ranger, setting 3 ships on fire while also spiking the guns of two forts protecting the port. Later in the day, Sailing across the bay to St. Mary's Isle, Scotland, the American captain planned to seize the Earl of Selkirk and hold him as a hostage to obtain better treatment for American prisoners of war. However, since the Earl was absent, the plan failed. *Editor: Note the differences in date. The source for April 25 listed on the preceding page is from NSSAR. Here is the source for this date:*

# CONSTITUTION OF THE REPUBLIC CHAPTER SONS OF THE AMERICAN REVOLUTION

#### Article 1 - Name

The name of this organization shall be the Republic Chapter Sons of the American Revolution.

#### Article 2 – Objects

The objects of this chapter are the same as defined at Article II of the Constitution of the National Society Sons of the American Revolution (NSSAR).

#### Article 3 – Eligibility for membership

Eligibility for membership is the same as defined at Article III of the Constitution of NSSAR.

#### **Article 4- Officers and Trustees**

Section 1. The officers of the Republic Chapter shall be a President, a Vice-President, a Secretary, a Treasurer, a Registrar, a Chaplin and a Trustee who shall be elected by a majority vote at a meeting prior to the beginning of the Chapter year and shall hold office for one year or until their successors are elected. All Chapter officers shall serve without compensation. Except for the office of President, one person may hold several elected positions.

Section 2. The President will appoint a nominating committee from the membership to develop a slate to be presented to the membership for their vote. Floor nominations for any position will be accepted at the election meeting. All nominees have to approve their nominations.

Section 3. The Republic Chapter will use the same election year as OSSAR.

#### **Article 5 – Meetings**

Meetings will be held as necessary to comply with Oregon Society Sons of the American Revolution (ORSSAR) meeting requirements.

#### **Article 6 – Parliamentary Authority**

The rules set forth in the most current edition of *Roberts Rules of Order, Newly Revised* shall govern the Republic Chapter and all meetings in which they are not inconsistent with NSSAR, ORSSAR State or this document.

#### **Article 7 – Amendments**

The Constitution may be amended by a two-thirds affirmative vote of the members present and voting a meeting of the Republic Chapter provided that at least thirty days' notice was provided to the Republic Chapter membership. Said notice will communicated by the most efficient means available. The 30 day notice will commence with the date of any mailings or if the notice is conducted by electronic means, the date the notice was sent electronically.

#### BYLAWS OF THE REPUBLIC CHAPTER SONS OF THE AMERICAN REVOLUTION

#### Bylaw number 1 – Officers, Powers and Duties

Duties of the Officers shall be as usually apply to their respective offices and such powers as directed by Republic Chapter membership. Officers shall report at Chapter meetings as required. Officers will report to the Oregon Society Sons of the American Revolution (OSSAR) as required by OSSAR. Officers will be installed annually following the National Society Sons of the American Revolution (NSSAR) guidelines.

#### Bylaw number 2 - President

The President serves as the Chief Executive Officer of the Republic Chapter. The President may delegate duties he deems appropriate to Republic Chapter members. The President shall attend ORSSAR Board of Managers (BOM) meetings when the BOM is holding meetings. The President will appoint committees as necessary to carry out the program of service for the Republic Chapter. The President is responsible for Republic Chapter reporting requirements to ORSSAR or NSSAR.

#### Bylaw number 3 - Vice-President

The Vice-President will perform duties as assigned by the President.

#### Bylaw number 4 – Secretary

The Secretary will record minutes at Republic Chapter meetings. The minutes will approved and used for documenting decisions that the Republic Chapter makes while conducting the mission of the Republic Chapter. The Secretary will keep a record of minutes.

#### Bylaw number 5 – Treasurer

The Treasurer will maintain the monies for the Republic Chapter. The Treasurer will present a Treasurers report at each meeting. The Treasurer will expend funds as approved.

#### Bylaw number 6 – Registrar

The Registrar shall be the official custodian for membership data of the Republic Chapter. The Registrar will make necessary membership reports to OSSAR and NSSAR as requested. The Registrar will have a membership roster published containing information approved by the Republic Chapter.

#### Bylaw number 7 - Chaplin

The Chaplin will perform duties as requested by the President.

#### Bylaw number 8 - Trustee

The Republic Chapter will comply with OSSAR guidance on the number of Trustees the Republic Chapter is allowed to have. The Trustee will attend the OSSAR BOM meetings. ORSSAR BOM voting requirements for chapter trustees are outline by OSSAR.

#### **Bylaw number 9 – Committees**

The President will form committees as necessary to perform the mission of the Republic Chapter.

#### Bylaw number 10 - Dissolution

In the event of dissolution, the procedures of OSSAR will be followed.

#### Bylaw number 11 - Amendments

The Bylaws may be amended by a two-thirds affirmative vote of the members present and voting a meeting of the Republic Chapter provided that at least thirty days' notice was provided to the Republic Chapter membership. Said notice will communicated by the most efficient means available. The 30 day notice will commence with the date of any mailings or if the notice is conducted by electronic means, the date the notice was sent electronically.
